What is a Crisis Pregnancy Center?

Reproductive Justice Action Milwaukee (RJAM) wants you to
...know your **real** options!



What is a CPC?

A crisis pregnancy center or “CPC” is a **fake anti-abortion clinic.**

These **fake clinics** are run by anti-abortion organizations to pressure pregnant people into carrying a pregnancy to term.

They masquerade as legitimate health clinics offering free pregnancy screening or ultrasounds - despite most having **no trained medical personnel present at the facility**. They will also use this opportunity to “counsel” (**lie to**) pregnant people about the effects of abortion and contraception. These lies have **no basis in medical research or science**. CPCs will also use **emotionally manipulative** tactics to guilt the pregnant individual out of an abortion.

The ultimate goal is to convince the pregnant person to continue a pregnancy by any means necessary.

These facilities are **not bound by HIPAA laws**, so they are **not required to protect your privacy** or confidentiality. This can include selling your information to third parties or notifying family that the individual visited for care.

The Truth About Their Lies

The Pill and Plan B are **not** “abortion pills”

Both medications prevent an egg from being released from the ovary, making it so sperm cannot reach the egg. **There is no abortion if there is no fertilized egg!**

Medication abortion **cannot** be “reversed”

The “abortion reversal” regimen CPCs offer has **not been approved** by medical and ethics boards. In fact, when studying “abortion reversal,” researchers from UC-Davis reported the regimen caused severe vaginal bleeding in study participants. Because of safety concerns for study participants and patients, research of this regimen has been halted. By contrast, **medication abortion has a better safety record than Tylenol!**

Abortion **does not** cause psychological trauma or post-abortion stress

In fact, a landmark study from UCSF found that, 5 years after their abortion, **over 95 percent of women said it was the right decision for them**. Although making the decision is often difficult, there is no evidence that women begin regretting their abortions over time. **ONLY YOU KNOW WHAT IS RIGHT FOR YOU. Your choices must be respected.**

There is **no link** between breast cancer and abortion

The biggest study done on abortion and breast cancer risk -- surveying over 1.5 million women in Denmark -- found no evidence of a link between induced abortion and breast cancer.

But What is the Danger?

A CPC in Massachusetts **failed to diagnose an ectopic pregnancy** when performing an ultrasound, according to a lawsuit filed in June 2023. The patient's lawyer indicated the ultrasound was performed by a person who “was not qualified to do this.” **The patient was sent to the hospital as a result, and nearly died.**

“...I am now 35 weeks pregnant with the baby they told me I would miscarry...”

This is a quote from an individual who sought care at a Wisconsin CPC. They were told by an untrained technician that they would miscarry their pregnancy as a means of preventing them from seeking abortion care. **This is the perfect scenario for these anti-abortion workers- a pregnant person that they conned into carrying an unwanted pregnancy.**
